4. The child support payments shall be made payable to the Clerk of this Court or to the appropriate agency designated by the Court to be transmitted to the State of Alabama, Department of Human Resources, where applicable.

The Defendant, wherever employed, shall include the child(ren) named above on any medical policy or medical insurance coverage at his/her place of employment or include the child(ren) named above on any medical insurance policy or medical insurance coverage which the Defendant may purchase, and to provide the evidence of such coverage to the State of Alabama, Department of Human Resources.
6. The Defendant is ordered to reimburse the State of Alabama the sum of \$ _____ to be paid as follows:

7. (A) new certificate(s) of birth, consistent with the findings of this court, shall be issued pursuant to the provisions of §§26-17-14 and 19, *Code of Alabama* 1975.

11. If the support payments are ordered paid directly to the Clerk of this Court, there shall be paid a \$1.00 administrative fee as provided in §12-19-26, *Code of Alabama* 1975, with each periodic payment.
